

Participation rules

2015 International Festival of Fashion Photography

Organization

The Talon Haut Company organizes the International Festival of Fashion Photography that is held yearly in the Palm Beach Casinosa s well as on the Croisette and at other locations in Cannes, where a collection of fashion photographs are exhibited that have been taken by fashion photographers from all over the world. After the Festival, the exhibition moves on to be shown in different casinos of the Partouche Group, as well as at other sites in Europe and throughout the world.

Rules

1. The International Festival of Fashion Photography is open to all fashion photographers in all countries.
2. Participation by photographers in the International Festival of Fashion Photography is free of charge and no participation fees are requested.
3. The number of photographers participating in the International Festival of Fashion Photography is not limited.
4. Only professional fashion photographers are admitted to present their photographs for selection to be exhibited in the International Festival of Fashion Photography.
5. Photographers may present a maximum of five photographs to the Artistic Committee of the International Festival of Fashion Photography. Photographs should be sent to the Talon Haut Company, located at 100 rue de la Folie Méricourt, 75011 Paris, by regular mail in a flat envelope, or dropped off at the offices of the Talon Haut Company at the address indicated, accompanied by a stamped envelop for return expedition.
Photographs must be presented in a 21x29.7cm format, accompanied by a properly completed registration form. **Photographs must be captioned by the photographer**, (name, surname, country, place of life and work).
Example: Marcelo Benfield, Argentine. Vit et travaille à Londres Photo réalisée pour le magazine Angloman / Marcelo Benfield, Argentina. Lives and works in London. Picture for Angloman Magazine.
6. Photographers may also address their photographs accompanied by a properly completed and signed registration form via e-mail to the following address: **tordjman.ruth@free.fr**
Photographs sent by e-mail should be presented in low definition.
Photographs presented must come from work done on order or have been taken for illustrating catalogs, advertisements or written articles. Photographs taken for the photographer's personal artistic explorations are also accepted.
7. The International Festival of Fashion Photography will never exhibit photos including real furs or weapons.
7. The deadline for presentation of applications set by the Talon Haut Company is **January 31, 2015**. The time limit for presentation is midnight on the day set by the Talon Haut Company. In consequence, photographs that arrive at the Talon Haut Company after the presentation deadline, even if they have been sent before this deadline, will not be considered for selection.
8. After deliberation by the Artistic Committee, photographers whose photographs have been selected will be requested to send the originals of these photographs in high definition on a Cd-rom so that the Talon Haut Company's partner laboratories may prepare prints.

In consequence, photographers whose photographs have been selected authorize the free representation and reproduction of these photographs within the framework of the International Festival of Fashion Photography and for promotional requirements related to the Festival, and this for the entire world for a ten-year period.
10. The photographer allows the Talon Haut Studio Company to surrender all or part of its rights as defined by this Agreement to any company of its choice and especially the ARTEXPO Association, partner of Cannes for the implementation of the International Festival of Photography Fashion.
11. Photographers guarantee the quiet enjoyment of photographs selected. They guarantee against all actions or claims by third parties, both concerning the original character of the photographs and rights pertaining to use of the image of persons and places photographed, in such a way that the Talon Haut Company, the International Festival of Fashion Photography and the organizations that welcome the exhibitions will be bothered by them.
12. Photographers whose photographs have been kept and exhibited authorize the Talon Haut Studio Company, as well as the organizer of the International Festival of Fashion Photography, to conserve the photographic prints, whatever their dimensions or format, for the purpose of being represented in a possible retrospective, and this without limit of time.
13. Photographers whose photographs are exhibited will be invited to take part in the different events of the International Festival of Fashion Photography, such as cocktails and closing dinner.
